Course Description

Special Problems in Environmental Engineering. 1-4 Credits, Max 8 Credits

Course Pre-Requisites / Co-Requisites

No pre-requisites, however a background in calculus and some experience with R is useful.

Course Objectives

Students will be able to implement reaction kinetic models to describe soil biogeochemistry, parameterize models using literature values, distinguish between models using 1) steady state analysis, 2) response to environmental perturbation, and 3) parameter sensitivity, document reproducible analysis pipelines, and give/receive constructive feedback.
