## Attendance Policy, Class Expectations, and Make-Up Policy

Class attendance is expected. While attendance is not recorded as a part of the course grade, students are responsible for any information communicated during class. Exam attendance is mandatory. Missed exams can only be made up when it is an excused absence. Excused absences must be consistent with university policies in the undergraduate catalog (<a href="https://catalog.ufl.edu/ugrad/current/regulations/info/attendance.aspx">https://catalog.ufl.edu/ugrad/current/regulations/info/attendance.aspx</a>) and require appropriate documentation. Student must contact the instructor as soon as the student knows that he/she will have an excused absence to arrange for makeup. Cell phones must not be used during class.

Our class sessions may be audio visually recorded for students in the class to refer back and for enrolled students who are unable to attend live. Students who participate with their camera engaged or utilize a profile image are agreeing to have their video or image recorded. If you are unwilling to consent to have your profile or video image recorded, be sure to keep your camera off and do not use a profile image. Likewise, students who un-mute during class and participate orally are agreeing to have their voices recorded. If you are not willing to consent to have your voice recorded during class, you will need to keep your mute button activated and communicate exclusively using the "chat" feature, which allows students to type questions and comments live. The chat will not be recorded or shared. As in all courses, unauthorized recording and unauthorized sharing of recorded materials is prohibited.

# **Evaluation of Grades**

Students are encouraged to work on homework in groups, but homework must be done individually. The standard for homework is that you must be able to explain what was done in the homework problem turned in and why. The exams will focus mainly on the material covered after the previous exam, however, because each class builds on previous material, students should be prepared to answer questions about any previously covered topic. Students are responsible for keeping returned homework, quizzes, and exams to be able to correct problems with recording of scores. In all cases involving grades, the student should wait at least 2 days after the problem is discovered (for a cooling off period) before talking to the instructor. All grades on exams, quizzes and homework becomes final 2 weeks after being returned to the class (a student not picking up an exam or homework does not constitute an extension to this deadline).

## **In-Class Recording**

Publication without permission of the instructor is prohibited. To "publish" means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.
